Travel by all students and employees is strongly discouraged – per UCF website. Students should exercise extreme caution with planning their travel. May need a more formal policy in the coming weeks. 			
Student Updates	<ul style="list-style-type: none"> • Requirements proposal <ul style="list-style-type: none"> ○ Lost about 6 weeks of clinical time in M3 due to virus. Most students will have to make up time in 4th year in addition to their current 4th year requirements. Students would like to explore the possibility of participating in more non-clinical activities to help them match. ○ There are no non-clinical requirements. Students are currently allowed to take up to 3 four-week blocks of nonclinical rotations. ○ Anticipate voting on reducing the clinical requirement by 4 weeks. ○ Concern that reducing the clinical requirements will dilute the 4th year. ○ Create a committee for exemptions? ○ Current requirements: AI, EM or Critical Care, and 6 rotations after that – 1 of which was a makeup from the 3rd year.
