M1/M2 Subcommittee

- Module Directors Update
 - Dr. Steve Lambert has decided to step down as module director of Cellular Function and Medical Genetics (HB1). Currently in the process of identifying a replacement.

- The Change in Grade Appeal Policy was approved by members. There is no change in the policy just a clarification in the policy as follows:
 - "A student may only appeal his or her module or clerkship grade, or any component there of (e.g., exam grade, narrative evaluation, clinical preceptor evaluation, project, etc.)"
 - "For appeal of grades in the M-3 or M-4 years, the appeal is directed to the Assistant Dean of Medical Education (M-1 and M-2). Appeals may not be initiated directly with other faculty or staff and attempts to do so may be considered a professionalism issue. The Associate Dean for Students must be copied on all communications regarding grade appeals."
