- ◆ Collaborated with UCF Lake Nona Hospital to provide Florida Board of Medicine CME requirements for physician licensure
- ◆ Required Opioid course was approved by the Florida Board of Medicine
- ◆ Initiated the Medallion Program. First 5 months 60 faculty up.
- ◆ 100% compliance of RAT Required Orientation to Clerkship
- ◆ First cohort of Master Resident Educator Certificate Program—29 enrolled in first cohort
- ◆ AI in education and educational research sessions and resources
- ◆ Initiated Teaching Sparks program for all COM faculty (BSBS, UME and GME faculty)
- ◆ On-Boarded **6** new Core Faculty members and **47** new preceptors across all clerkships
- ◆ Continuation of Clinical Teaching Certificate Program with 2 additional cohorts in 2024 Spring 2024 (10 participants) and Fall 2024 (8 participants)

- ◆ Hired Madelynn Verkleeren as a new Assistant Director with responsibilities for program evaluation, COM awards, the Medallion Program, and Faculty Check-ins
- ◆ We moved to an open nomination process for our Faculty Award process, welcoming nominations from anyone within our academic community. We then required responses from the nominee to provide additional information to us based on the award criteria. These adjustments aimed at enhancing the nomination process to help ensure that deserving candidates receive proper recognition. For 2024, 17 awards were given out.
- ◆ The Resident Excellence in Teaching Clerkship awards will now be given in the spring at the Resident Graduation Ceremonies. This change has been positively received and will be based on each resident's performance as teachers in the 24/25 academic year.
